Catherine Schock, long time Editor & Publisher of the Ridgeback Rambles, has passed those duties to David T. Hayek.

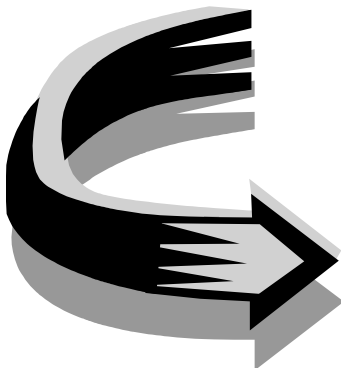

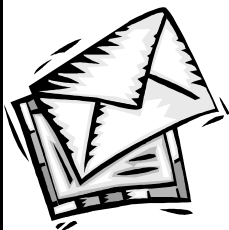

BREED TEMPERAMENT AND TESTING (continued from Page 1)

sure the breed is advancing and developing in a positive direction. In this sense we do not only look at conformation but we also need to consider our dogs' health status and temperament. Most of today's breeders use canine individuals with good mentality and temperament in breeding programs. The temperament of both the stud dog and the brood bitch are equally important for a prospective breeding, especially when it comes down to comparing prospective pedigrees and show results. But the question remains: What really constitutes a good temperament in a dog?

The Swedish Civil Service Organization for Service Dogs has, since the 1950's, temperament tested many working and herding breeds. In the late 1990's, using specially developed temperament tests, the results were compiled into breed specific mental maps. The Swedish Rhodesian Ridgeback Club (SRRS), a parent club and active partner of the Swedish Kennel Club has started to test the RR breeding stock in the country. Today 2001, some 300 + individuals have been tested so far on a voluntary basis and a mental map is slowly being developed describing the behaviors of the Rhodesian Ridgeback breed.



Dr. Christina A. Wistrom, Of Afrikka Kennels, is a club member of the OCRRC, RRCUS and the Swedish Rhodesian Ridgeback Club,. Dr. Wistrom spent the summer of 2001 as a participant and observer at some Swedish Mental Testing Events of RR's. Dr Wistrom has agreed to give the general OCRRC membership a presentation of the current status of RR mental temperament testing programs that are currently underway within the Swedish RR club. The presentation will include actual video segments of RR's from different testing situations. Dr Wistrom will also discuss and include puppy temperament testing, puppy testing protocols as well as testing protocols for young RR 12 months and above.

The Ridgeback Rambles encourages all members to attend the general meeting and participate in Dr. Wistrom's presentation.

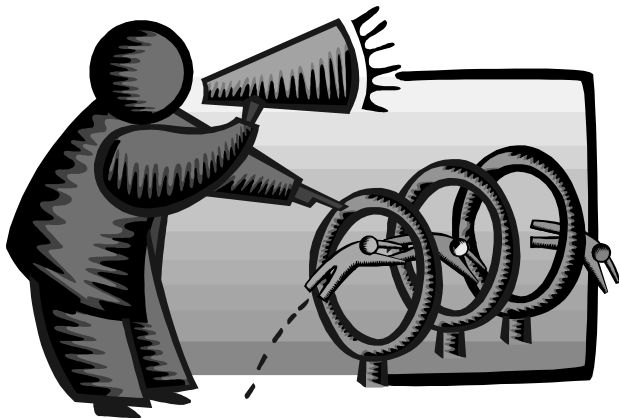
